Introduction:

This is a request for the City Council to approve Resolution 2022-26, CRA Budget Amendment to Fiscal Year 2021-2022 Budget.

Discussion:

Rebudgeting requires City Council approval when the revenue and expenditures are increased or decreased from the original approved budget. The City Council must provide formal budget approval that recognizes the unanticipated revenues and expenditures. The budget amendments which are recommended are included in Exhibit "A" of Resolution 2022-26, and reflect increases or decreases of accounts for revenues and expenditures of each affected fund.

A RESOLUTION OF THE COMMUNITY REDEVELOPMENT AGENCY OF THE CITY OF MOUNT DORA, FLORIDA AMENDING THE FISCAL YEAR 2021-2022 BUDGET; PROVIDING FOR LEGISLATIVE FINDINGS AND INTENT; PROVIDING FOR APPROVAL OF BUDGET AMENDMENT; PROVIDING FOR THE IMPLEMENTATION OF ADMINISTRATIVE ACTIONS; PROVIDING A SAVINGS CLAUSE; PROVIDING FOR SCRIVENER'S ERRORS; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Mount Dora Community Redevelopment Agency (CRA) is charged with redevelopment activities within its boundaries to sustain and enhance the tax base; and

WHEREAS, the CRA must adopt an annual budget that complies with state law and the operative Redevelopment Plan 2019; and

WHEREAS, the CRA adopted the Fiscal Year 2021-22 Budget through CRA Resolution No. 2021-94 (CRA), and

WHEREAS, on February 1, 2022, the CRA adopted the amended Fiscal Year 2021-22 Budget through CRA Resolution No. 2022-10 (CRA), and

WHEREAS, pursuant to Florida Statutes, Section 189.016, the CRA may amend its budget to account for unanticipated revenues; and

WHEREAS, the CRA has determined that it is necessary to amend its 2021-22 budget to as set forth in **Exhibit "A"** attached hereto.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMUNITY REDEVELOPMENT AGENCY OF THE CITY OF MOUNT DORA, FLORIDA, AS FOLLOWS:

SECTION 1. Legislative Findings and Intent. The CRA has complied with all requirements and procedures of Florida law in processing this Resolution. The above recitals are hereby adopted.

SECTION 2. Approval of Budget Amendment. The CRA hereby approves the Fiscal Year 2021-2022 Budget as amended in **Exhibit "A"**.

SECTION 3. Implementing Administrative Actions. The City Manager, City Attorney, and the CRA Administrator are hereby authorized and directed to take such action as may be deemed necessary and appropriate in order to implement the provisions of this Resolution. The

City Manager may, as deemed appropriate, necessary and convenient, delegate the powers of implementation as herein set forth to such City employees as deemed effectual and prudent.

SECTION 4. Savings Clause. All prior actions of the CRA pertaining to the adjustment to the Fiscal Year 2021-22 Budget, as well as any and all matters relating thereto, are hereby ratified and affirmed consistent with the provisions of this Resolution.

SECTION 5. Scrivener's Errors. Typographical errors and other matters of a similar nature that do not affect the intent of this Resolution, as determined by the City Clerk and City Attorney, may be corrected.

SECTION 6. Conflicts. All Resolutions or parts of Resolutions in conflict with any of the provisions of this Resolution are hereby repealed.

SECTION 7. Severability. If any Section or portion of a Section of this Resolution proves to be invalid, unlawful, or unconstitutional, it shall not be held to invalidate or impair the validity, force, or effect of any other Section or part of this Resolution.

SECTION 8. Effective Date. This Resolution shall become effective immediately upon its passage and adoption.


